

Kilcock Golf Club Bye Laws

The following BYE LAWS shall be deemed to have been made subject to and in accordance with Rule 28 of the Constitution

General:

- 1. No dogs shall at any time be allowed in the clubhouse, or on the course. Guide dogs for the visually impaired accompanied by their owners are exempt from the Bye-law.
- 2. Proper dress, appropriate for golf, must be worn at all times See Club Dress code
- 3. Please be aware of others in the vicinity if using mobile phones
- 4. All players must have their own golf bag/clubs. the sharing of a golf bag is strictly prohibited
- 5. Members are encouraged to wear club jumpers. If representing the Club, the wearing of a club jumper is essential
- 6. Neat dress is essential at all times in the clubhouse see Club Dress code
- 7. The visitors' book must be signed by all non-members and co-signed by a member. Green fees are deemed to be temporary members for the day and are not required to sign the visitors' book

Etiquette:

- 8. Divots must be replaced, and pitch marks repaired
- 9. In taking practice swings, players shall avoid causing damage to the course, particularly the tee, by removing divots
- 10. No one share move, talk or stand close to or directly behind the ball or the hole when a player is addressing the ball or making a stroke
- 11. Players shall carefully fill up any holes made by them in a sand bunker and leave the bunker in a condition in which they would expect to find it.
- 12. Players shall not damage or permit their caddies to damage the putting greens, by dropping clubs, by careless handling of the flagsticks or by standing close to the hole
- 13. When the play of a hole has been completed, the flagstick shall be properly replaced in the hole before the players leave the putting green and thee players shall immediately leave the putting green
- 14. Buggies shall not be brought onto the tees or greens or banks

Other:

- 15. Complaints regarding any matter on the course or in the clubhouse or its environs will only be dealt with if the complaint is put in writing to the Honorary Secretary. Complaints directly related to competitions should be put in writing, on the day of the competition, to the (relevant) Honorary Competition Secretary
- 16. Foul or abusive language or unseemly behaviour on the course, in the clubhouse, or its environs is unacceptable. Should such behaviour result in a formal complaint to the Joint

- Management Committee, sanctions may be applied up to and including suspension of membership.
- 17. Players including members or their guests and temporary members shall obey at all times the instructions given by the course ranger who shall have been previously authorised to act in that capacity by the Joint Management Committee either for a specific competition or in respect of all competitions. A course ranger may be authorised by the Joint Management Committee to oversee general payment of green fees, behaviour on the golf course or in in environs and any other matters including those set out in the Terms of Competitions and Bye Laws
